**NOTES:**

- 1) Fixed prices (excluding courier ETGB) are collected per declaration. If there are carriages (if any) required for recalls, they are charged separately.
- 2) In the recall processes, export additional storage fee is charged in addition to Recall Fee for periods after 24 hours.
- 3) The export storage fee exemption authorization belongs to Cargo Directorate.
- 4) This is applicable to Istanbul only.
- 5) The total fee to be collected is calculated as rounded up and in multiples of TL 5.
- 6) For the cargoes that have entered the warehouse, but the AWB of which will be revised, the storage fee calculation is based on their warehouse entry date; besides, the changed label price is collected.
- 7) Warehouse fees are calculated according to the tariff effective from the time the cargo arrives at the warehouse.
- 8) ULDs that are lent, will be priced at the rates which specified in the "ULD Replacement, Rental and Repair Schedule".
- 9) Wheelchair shipments that are not more than one, are not transported for commercial purposes and when the consignee is not arranged as a legal entity in the bill of lading, these shipments are exempted from the above tariffs upon instruction of the Disability Health Board Report.
- 10) For cargo weighing 3 tons or more in one piece, crane and forklift costs belong to the customer.
- 11) Starting from 07.01.2025, Export cargoes will be charged via CW.
- 12) 8.22.1 - TK Live Pet Supervision Service includes walking, escorting on tarmac, photo sharing processes and real time communication service. The service is charged with according to number of kennel. Those shipments having 7 or more kennels are charged with the maximum price, ₺17.500.
- 8.22.2 - TK Live DOC (Day-Old Chick) Supervision Service includes escorting on tarmac and photo sharing processes.
- 13) For flights with a scheduled departure time of 23:59 on Monday, storage fee will not be charged for cargo that enters the warehouse on Friday.
